Cllr. Neil Compson to obtain prices for a brass noticeboard.
- 2677 Weight Restriction Request - Seisdon Holloway and Fox Road
A Meeting was held to discuss proposed quarry at Shipley. It was resolved the Parish Council will not object to the planning application. Mr. Andrew Haden of Shipley was informed that dust from Seisdon quarry has been a problem in the village.
- 2683 Noticeboards
Mastercraft have a noticeboard for £650.00 plus VAT which would meet the criteria and Cllr. Neil Compson is meeting a representative to discuss this.
- 2692 Gardenland, Bridgnorth Road - accident/signage
Planning Officer has informed the Council a planning application has not been submitted for the signs outside Gardenland and this will be investigated.
- 2708 Traffic Lights, Fox Road/Bridgnorth Road junction
Clerk to e-mail C.Cllr. Mrs. Wilson asking her to liaise with Highways with a view to securing traffic lights through a Section 106 agreement subject to Shropshire County Council granting planning permission for Shipley Quarry. Mr. Bishop offered to find out how many accidents/fatalities have occurred along Bridgnorth Road in the area of Shipley.
- 2724 SID signs/Community Speed Watch
The Chairman will get in touch with C.Cllr. Mrs. Wilson and sign up for CWS. Wombourne have a speed gun and will share this with Trysull & Seisdon.
Mr. Keeling has stated Highways are not taking on any new sites for SID signs at the present time.
- 2728 Code of Conduct training

- 2729 Date Protection

Litter pick requested for Fox Road, Seisdon. Clerk to request litter pick along Trysull Holloway.

2736 Freedom of Information

The Clerk reported the Freedom of Information request has been dealt with.

Highways

C.Cllr. Victoria Wilson has requested a list of outstanding highway matters and the Clerk reported she has forwarded this information.

Oak Drive payment

Reply from Mark Keeling stating this pavement features within their forward programmes for structural resurfacing. It is not suitable for slurry seal treatment.

The Smithy, Seisdon - If the elected member is prepared to fund knowing the issues with the adjoining property, the owner of the property can be contacted regarding consent.

Wombourne Road (4014672) Replacing bollards remains low priority.

Wombourne Road - Village entrance sign has been added to County Councillor's list.

Awbridge Cottage (4092698) - blocked drain outside Awbridge Cottage. Water filling fire hydrant chamber which is situated next to the drain.

Union Lane (Enquiry 4092690 /4044624) Works have been raised to have the potholes repaired by Awbridge Cottage and outside C.P.Bolland.

Meadow Farm (Enquiry 4058828) Three blocked drains.

Bridgnorth Road (Enquiry 4093515) Pushed up tarmac. Repairs grouped with similar works in area.

Overgrown bush, Seisdon Road (enquiry 4062879) This is to be cut back.

Broken bollard, Ebstree Road (Enquiry 4093513) Inspected and not felt to be a high risk and repairs will be grouped with similar works in the area.

Flooding (enquiry (4096553) School Road footpath between the School and the Community Car park totally flooded. Clerk to request cleaning out of drains. Flooding also on corner of School Road/Feiashill Road, Trysull and on corner of Crockington Lane. E-mail from Cllr. Mrs. Wilson stating she has been complaining about this and Highways are updating Amey.

Fox Close and The Green (Enquiry 4083810) Hedge has been cut back but weeds on footpath have not been removed.

Bell Road (Enquiry 4099123) -Pothole by lane to rear of Trysull Holloway.

Crockington Lane (Enquiry 4099119) - in front of driveway lefthand side before Crockington Close.

Clive Road (Enquiry 4109024) Tarmac breaking up in Clive Road opposite the car park entrance to the Fox of Shipley.

Seisdon Road, Trysull (Enquiry 41162230) Very low kerb in front of new development.

School Road, Trysull (enquiry 4116239) Footpath covered in mud from School to Car Park.

School Road, Trysull (enquiry 4116227) Broken branches from bushes and trees on grass verge. Other branches need to be cut back. Area very untidy.

Potholes, Bratch Common Road, Trysull (enquiry 4116220) Two deep potholes 100 metres from Wombourne Road on left hand side.
